- Increasing focus on value added opportunities through provision of ingredient solutions.



Key Highlights

- HPP remains the only vertically integrated macadamia player from farm to brand in the world with leading position in USA, the largest consumer market of its current use as healthy snacks and confectionary
- Strategic Review of Kapua Orchard has uncovered a range of opportunities for industry consolidation given the current demand/supply cycles
- Value added solutions remains a largely untapped area for further exploration
- HPP is well placed to be a meaningful industry participant.
