


#### Traditional 'long only' fund



## We Generate Alpha from Both Long and Short Positions...




#### **Gross Long and Short Alpha Since Inception**



#### Our Market Neutral Strategy is True to Label...




#### **Net Market Exposure – Opal Market Neutral Fund**
